**Objectives:** The seminar will provide a hands on training on the application of the European Arrest Warrant (EAW) on an advanced level, yet at the same time, go beyond the specific instrument and examine its application in the broader context of ensuring the adequate protection of fundamental rights.

The detailed practice oriented understanding of the EAW will be then complemented with the examination of the fundamental rights issues triggered by the issuing and execution of EAWs, in particular questions related to procedural guarantees and conditions of detention (c.f. C-404/15 and C-659/15 PPU Aranyosi and Caldaruru and C-220/18 PPU ML).

A detailed examination will be offered of the C-182/15 Petruhhin judgment and its effect on third country extradition requests. On the basis of the judgment the interconnection between the EU Charter on Fundamental Rights and EU citizenship rights and the EAW will be discussed.
